

RESOLUTION 28-2009

**RESOLUTION OF THE TOWNSHIP OF BRISTOL, BUCKS COUNTY,
PENNSYLVANIA AUTHORIZING AN INCREASE IN THE WATER
RATES CHARGED BY THE TOWNSHIP OF BRISTOL**

WHEREAS, the Township of Bristol, Bucks County, Pennsylvania is authorized under the Pennsylvania First Class Township Code to recover its water costs by an assessment of user fees against those purchasing water from the Township; and

WHEREAS, there has been a rate increase in August of 2008 by the Aqua PA Water Company of 50% per thousand gallons in the cost of water to Bristol Township; and

WHEREAS, an increase in water rates charged by the Township is necessary to cover the Township's increased costs to provide and purchase water,

NOW, THEREFORE, the Council of the Township of Bristol, Bucks County, Pennsylvania does hereby Resolve the following.

SECTION 1. The appropriate Township officials and departments shall increase the current per gallon water rates charged by the Township by ten percent (10%) with said increase being affective October 1, 2009.

SECTION 2. A. Beginning October 1, 2009, the allocated gallon water rates charged by Bristol Township shall be:


